\*This fee will provide each vendor with a 10'x10' space, 8 ft table and 2 chairs. **Please note tents are not included in this cost.** Vendors may bring their own tent and set up in their assigned spot or rent tents from Surati's tent rental company. Tents may not be bigger than 10'x10' in dimension unless pre-approved by Surati in writing upon special request by the vendor. To avoid any bottlenecks only the Surati contracted tent company trucks will be allowed access to set up tents at the venue. Tent rental cost is additional. In case vendors need to rent a tent they must do so directly with the tent company and note their deadlines to order. \*\*Food and liquor vendors / restaurants must obtain and submit proof of permit to Surati and to the Jersey City Health Department prior to the event.
